## Fire Causes Move of Cars

Willimantic, CT. Sunday, 11/9/08. James Key, Howard Raphaelson, and Rich Cizik, Jr. were at the museum discussing the day's events and working on various projects. Around 4PM Howard left and shortly thereafter James also left. As I was getting back the project I was working on I received a call from James saying the driveway was blocked by a fire truck. The firemen were in the process of hosing down the interior of the No. 3841 baggage car. Mark Granville, Jeff Laverty, and Cliff Lund were also down there by the time I closed up and got to the baggage car. Apparently someone squeezed into the baggage car through the west door which was secured by a cable. There was just enough slack in the cable to allow the person through. This individual took a piece of PVC sewer pipe, about 18" long, stuffed it with paper, leaned it against the left jamb of the southwest baggage car door and lit it. Luckily someone saw it and called the fire department. The firemen broke through the compound gate and squeezed

in through the cabled door to open the slides to start putting the fire out. Results of all this is there is a 7" scorch mark on the floor and a small section of the wall was charred through about 1/2 of a layer of siding. Also there was some light charring above that all the way up to the clearstory roof. It could have been a lot worse if the call hadn't gone out so soon.

## Preparing to Move the Cars...

Willimantic, CT. Tuesday, 11/11/08. Walt Dumas, Dick Arnold, Rolf Johnson, Cliff Lund, Bob Hassett, Carolyn Stanich, and I met at the compound for the next phase of our project. Walt and Cliff started clearing the flange ways where the track crossed driveway. While they were doing that I started to hack back the brush and vines in the track and switch areas to determine what ties needed to be replaced. Shortly afterwards Dick and Rolf showed up and said a minimum of three ties needed to be replaced for safety reasons. Place one under the switch points and the other two under the frog for the siding. Also since

the switch stand for the second yard track was missing it was decided to clamp the points of the switch closed using the clamps from a gauge bar and the length of threaded rod. Around mid-day Carolyn made a few trips with the three wheeled vehicle for more items needed to complete the project. It took most of the day to switch out and tamp the timbers. Around 3:30PM we were ready to get the 25 ton locomotive to start moving the cars out of the compound.

## The Move.....

So while Cliff and I cleared the tracks and put various car parts into the baggage car, Rolf, Dick, and Bob brought the 25 ton locomotive back along with some oil. This would be used for the bearings of the two cars. The cars were then pulled out of the compound one at a time and placed on the Air Line track. Once both cars were out, they were recoupled. After everything was checked and double-checked, the compound gate was closed, and the train headed west towards the museum. It's been sometime since a passenger train consisting of a baggage car and coach had traveled along the Air Line. The train arrived at the museum around 4:30PM. The cars are currently sitting inside the fence at the east end of the museum.

## Yankee Silversmith Car No. 104 - Coming to Willimantic

There used to be a popular restaurant located near the junctions of Route 5 and Route 15. It was pretty easy to see since there was nicely decorated railroad coach located right in front of the restaurant. The restaurant's name was the Yankee Silversmith Inn.

The coach that stood in front of the restaurant started out as the Philadelphia & Reading Railroad No. 910, either built in 1892 by Pullman Car Works as a class PAg or in 1902 by Osgood Bradley as a class Pak car. Either way she was built as either a First Class or Parlor car, as the interior is outfitted with Quatersawn Oak that has some nice inlaid ribbon like veneer work. In December 1926 Belfast & Moosehead lake Railroad in Belfast, ME, purchased the car and one other car from the Philadelphia & Reading, and it

became B&ML No. 11. In 1960 the Black River & Western Railroad located in Ringos, NJ purchased the car and it became BR&W No. 104. In August 1970 the owner of the Yankee Silversmith Inn of Wallingford, CT purchased the car and brought it to Meriden, CT on flat cars. Trucks were on one car and the body was on another. On August 26<sup>th</sup>, 1970 there was a small parade from the Meriden railroad yard to the site of the inn where a panel track was put in place for the car to sit on.

In July 2007 there was a fire in the attic of the inn and the subsequent water damage from the sprinklers was too much to repair and keep the inn open. Luckily the sprinklers in the coach did not activate. So the owners approached multiple historical societies to see if anyone was interested in the coach. Some were interested, but the quotes from moving and storage companies were much too expensive to accept. For us, we got a break as we found an affordable way to move the car. A museum member stepped forward to front the funds for the move, of which one half will be a three year loan and the other half will be considered a donation. Currently the cars are located just inside the east gate just before you get to the main entrance to the museum village area.
